Background

The NYSDOH and its planning partners have continued their efforts to streamline and enhance healthcare facility coastal storm planning.

The HEC HCF Guidance is designed to provide HCFs in New York City and the adjacent counties of Westchester, Nassau and Suffolk with an overview of important concepts and procedures that need to be known and understood in order to plan for, respond to and recover from a large scale, multi-facility, multi-jurisdictional evacuation event related to a coastal storm.

Goal

To provide updates and revisions regarding the 2016 HEC HCF Guidance. Overview of Guidance will include key areas of coastal storm planning that are important to health care facilities:

- HEC procedures and time lines;
• Types of information needed for evacuation;
• Request for temporary suspension of regulations (waivers); and
• Transportation Assistance Levels (TALS).
• Question and Answer section that addresses many common issues faced by health care facilities.

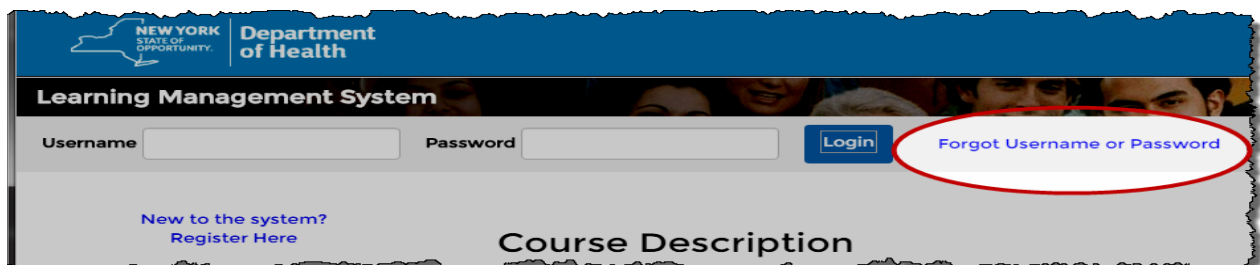
1. If you already have a LMS Username and Password then login and proceed to step 3.

If you do NOT have a LMS Username or Password then select **NEW TO SYSTEM** button to register and complete the registration form.

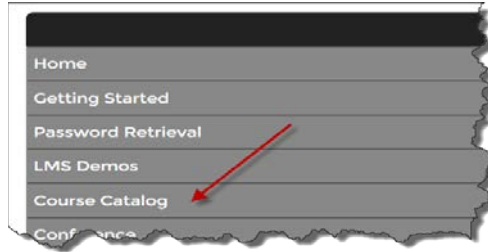
